Missouri Firearms Safety Instructor Qualification Form

I **affirm** that I am a qualified firearms safety instructor, as defined in 571.111, RSMo, in that:

Certificate of Firearms Safety Training Course

With One Hour Classroom or Online Safety Training

I **affirm** that the applicant (named above) has taken and passed a firearms safety course taught by me, a qualified firearms safety instructor that included:

- (1) The applicant presenting to me, a qualified firearms safety instructor, proof that the applicant has passed a regular or online course on firearm safety conducted by an instructor certified by the National Rifle Association that is at least one hour in length;
- (2) Handgun safety in the classroom, at home, on the firing range and while carrying the firearm;
- (3) A physical demonstration performed by the applicant that demonstrated his or her ability to safely load and unload either a revolver or a semiautomatic pistol and demonstrated his or her marksmanship with either firearm;
- (4) The requirements of this state for obtaining a concealed carry permit from the sheriff of the individual's county of residence;
- (5) The laws relating to firearms as prescribed in chapter (RSMO 571);
- (6) Laws relating to the justifiable use of force as prescribed in chapter 563 RSMo.

- (7) A live firing exercise of sufficient duration for each applicant to fire either a revolver or a semiautomatic pistol, from a standing position or its equivalent, a minimum of twenty (20) rounds from either handgun at a distance of seven yards from a B-27 silhouette target or an equivalent target; and
- (8) A live fire test administered to the applicant while the instructor was present of twenty rounds from either handgun from a standing position or its equivalent at a distance from a B-27 silhouette target, or an equivalent target, of seven yards

I understand that if I knowingly provide any law enforcement officer with any false information concerning an applicant's performance on any portion of the required training and qualification, I shall be guilty of a class C misdemeanor. By affixing my name hereto I affirm the declaration contained herein. I agree, in compliance with RSMo 571.111, to make the applicant's course records available upon request to the sheriff of the county in which the applicant resides and to maintain all course records on students for a period of no less than four years from course completion date.
