# Individual Subscription To MSA On-Line Learning Management System

The Missouri Sheriffs' Association (MSA) is now offering an individual subscription service for our on-Line Learning Management System (LMS). The MSA LMS Individual Subscription guarantees the subscriber the ability to complete all of their POST required annual CLEE training with the exception of the 2-hour Skill Development/Firearms training requirement. There are currently over 100 courses available to choose from, which would cost over \$500 to pay for individually.

#### PRE-REQUISITES:

If you do not already have an MSA LMS on-line training account set up, please go to <a href="https://lms.mosheriffs.com">https://lms.mosheriffs.com</a> to register and set up an account. Make sure you use the same email address you used to set up your MSA LMS on-line training account when you sign up for an MSA LMS Individual Subscription.
